In connection with such offering, the underwriters reimbursed the Issuer for any discounts and commissions payable by the Issuer with respect to the Acquired Shares (the "Discount"). The Issuer in turn paid a fee equal to the amount of the Discount to Alchem Limited totaling \$406,250 (the "Fee"), or \$0.325 per share. The \$5.00 per share price does not reflect payment of the Fee to Alchem Limited.
- Represents shares of the Issuer held by Alchem Limited. Harsaul Foundation is the indirect owner of Alchem Limited. As a result, Harsaul Foundation may be deemed to share voting and investment power with respect to the shares held by Alchem Limited.
